Nine years ago, my 12-year-old son began volunteering at Freedom Service Dogs. Inspired by the mission, the passion in his voice was evident: "Dad! You've got to check out this organization!" Like many of you, my passion deepens each year... especially when I hear from those who have been given a Freedom Service Dog. You will read their stories of transformation and triumph in our 2015 Annual Report. Each story would not have been possible without the vision and compassion of our founders, Michael and PJ Roche.

As we mourn the recent loss of Michael, we are more committed than ever to their vision that inspires our work: Transforming shelter dogs into service dogs for people who are living with disabilities. Michael and PJ believed in second chances and breaking through barriers. Using a wheelchair didn't stop Michael from living his life to the fullest and a stint as a shelter dog didn't stop Oreo from transforming Michael's life.

You have demonstrated your unwavering belief in second chances. Your support in 2015 helped Freedom Service Dogs transform the lives of shelter dogs as well as their human partners. Together with dedicated volunteers, loyal donors, visionary partners, devoted board members and staff, faithful dogs and brave clients, the Freedom Service Dogs community can stand proud. In 2015:

▶ 29 clients on the waiting list received a custom-trained service dog or professional therapy dog.

- ▶ More than 6,715 donors invested over \$3.1M.
- ▶ Volunteers dedicated an amazing 8,445 hours—the equivalent of 4.2 full-time employees.
- ▶ For the second year in a row, Charity Navigator rated Freedom Service Dogs four stars - fewer than 20 percent of the organizations they rate receive back-to-back four-star ratings.
- ▶ Our devoted and expert trainers upheld the high standards of Assistance Dogs International accreditation.

You helped make 2015 a pivotal year for the individuals on our waiting list and dogs in our training program. We are so grateful that you've chosen to partner with us.

As we strive to carry out the initial vision of the Roches, we are reminded that the demand for a Freedom Service dog remains a barrier for the people on our

waiting list. Therefore, we have embarked on a capital campaign that will allow us to double the number of people we serve in a more timely manner.

You will find details on our expansion plans in this report and we invite you to join us in creating a lasting legacy by donating to the building fund, the veterans' program, dog training or another aspect of our mission that calls out to you. Your donation, whether monetary or in-kind, will transform even more shelter dogs into service dogs for deserving individuals on our waiting list who so desperately need the partner that can only be found in a four-legged companion. 🐾

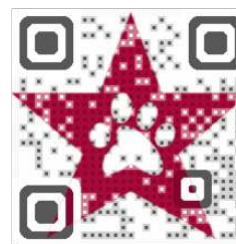
Our new Home

TRANSFORMING OUR NEW BUILDING INTO A HOME

If you've been to our current facility, you'll know that we have outgrown our space. Not only is it inadequate to meet the needs of the people on our waiting list but it also sits on the 100-year-flood plain, making expansion impossible.

A \$2 MILLION RENOVATION IN THE WORKS

Since 2010, more than 300 donors contributed over \$2.4 million to fund the purchase of our new home! Our board looked at more than 70 properties before settling on a location that our donors enabled us to purchase in July 2015. Our new home sits on 1.46 acres with an adjoining 1.1 acre lot that is ideal for outdoor kennels and play yards. The indoor space consists of 22,680 square feet versus our current 10,000 square feet. Working with Siemens, an internationally renowned engineering company, we have created a build-out plan to transform the building into the exact home we need. The total amount needed to renovate is \$2 million.

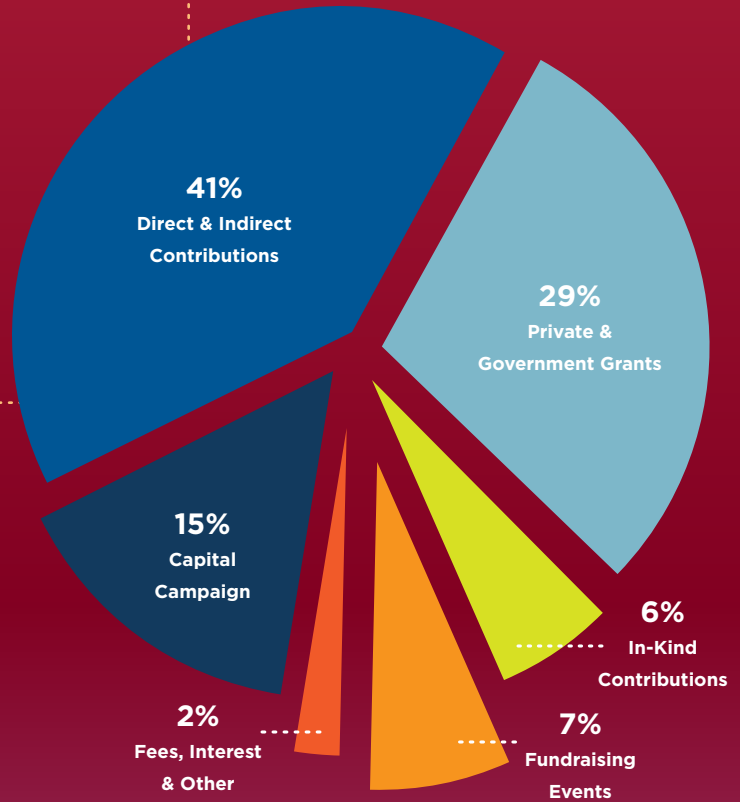
